#### V. RULES OF DECORUM

Presbytery **APPROVED** the following Rules of Decorum.

#### Report #1a - Rules of Decorum

- 1. That these be the guidelines for the conducting of business at this meeting:
  - a. Out of courtesy, when Presbytery is debating, all remarks shall be addressed to the moderator and shall be made from the floor.
  - b. In the interest of time and to allow as many as possible to speak, speeches will be strictly limited to 2 minutes. Persons wishing to speak should move to the appropriate microphone. So there is clarity, a speaker should begin by saying, "I speak for (or

- against) the amendment..."The moderator will rotate between calling on a person in favor, and then a person opposed, etc.
- c. Remarks shall be confined to the pending question. The moderator will interrupt if in his/her judgment the speaker has drifted from the pending question.
- d. Commissioners may not refer adversely to prior acts of Presbytery not pending now.
- e. Remarks shall not impugn another commissioner or that person's motives.
- f. Distribution of reports or documents shall not be done during the meeting.
- g. Commissioners shall not disturb the meeting, by applause or verbal response to remarks made by a commissioner, or in response to a vote.
- h. Each commissioner may speak twice on a subject but may not speak the second time until everyone who wishes has spoken.
- i. Any docket time allocated to a presbytery entity should not be used for fundraising purposes, capital or otherwise, unless approved by CT prior to that presbytery meeting.

#### XV. REPORT FROM THE REVIEW OF PRESBYTERY DESIGN TASK FORCE

Chair Catherine Robinson presented the Final Report from the Presbytery Design Task Force and highlighted the recommendations based on the Task Force's findings. These recommendations require changes to the Standing Rules with regards to the size of the Networking Committees and the structure of the Finance and Property Committee. Stated Clerk Stephen Rhoades presented the First Reading of Revisions in the Standing Rules based on the Task Force's recommendations. The Presbytery heard discussion about the need to include congregational development in the Presbytery design and concern about keeping stewardship separate from finances in order to focus on gratitude. The Coordinating Team will evaluate the recommendations of the Task Force further and present revisions at the October meeting.

#### XVI. REPORT FROM THE CAMINO DE VIDA TASK FORCE

#### XX. REPORT FROM THE COORDINATING TEAM

The Presbytery RECEIVED the Report from the Coordinating Team as part of the Consent Agenda. Moderator Finch explained that at the February meeting, two logo options were clearly preferred. Leadership Team and Coordinating Team felt it would be difficult to combine these options and that a vote between the two would be conducted at this meeting. Chair Nelson Capitan spoke about the Presbytery's efforts to receive affirmation from Zia Pueblo. Due to the COVID pandemic, the Pueblo Council had not reconvened. A vote between the two logos was

conducted through an online poll. The Presbytery **APPROVED** selecting Logo A as new logo for the Presbytery of Santa Fe.

#### 1. NEW PASTORS RECEIVED AND/OR ORDAINED AND/OR INSTALLED

In April, COM approved the Rev. **Laura Loving** as a temporary member of the Presbytery while she is the Stated Supply and Moderator of Session at Albuquerque, New Life.

#### 2. PASTORAL CALLS AMENDED OR DISSOLVED

In March, COM approved changing the Belen, First, Pastoral Call to the Rev. **Jayne Ruiz** to half-time, effective March 1, 2020.

In May, COM agreed with the Congregation at Angel Fire, United Church and the Rev. **Richard Safford**, to dissolve their Pastoral Call effective June 30, 2020, upon his retirement.

In May, COM agreed with the Congregation at Belen, First, and the Rev. **Jayne Ruiz**, to dissolve their Pastoral Call effective June 30, 2020, upon her retirement.

In May, COM agreed with the Congregation at Raton, First, and the Rev **John McGarey**, to dissolve their Pastoral Call effective June 30, 2020, upon his retirement.

#### 3. CONTRACTS APPROVED/DISSOLVED for Temporary Pastoral Positions:

In June, COM approved the resignation, effective July 31, 2020, of the Rev. **Ken Cuthbertson** as a Parish Associate at Las Placitas Presbyterian Church.

In June, COM approved the resignation of the Rev. **Laura Loving** as Stated Supply pastor at Albuquerque, New Life, effective May 30, 2020.

In June, COM approved the dissolution of the co-Interim Pastor contract at Santa Fe, Westminster, with the Rev. **Christine Vogel**, effective June 30, 2020.

In June, COM approved the extension of the contract between Santa Fe, Westminster, and the Rev. **Lee Walters**, as they move from two co-Interim Pastors to one Interim Pastor, effective July 1, 2020.

In June, COM approved the resignation of the Rev. **Linda Loving** as Stated Supply pastor at Dixon, Embudo, effective June 30, 2020.

In July, COM approved the continuation of the 3/4 time Interim Pastor contract between the Placitas, Las Placitas Presbyterian Church and the Rev. **Bill Humphreys**, effective July 1, 2020, and the seasonal reduction of this contract to 1/2 time April - May (April COM meeting) and then indefinitely during the COVID-19 quarantine season.

#### 4. CHANGE IN MINISTERIAL STATUS:

In March, COM approved moving the membership of the Rev. **John Camp** to the Presbytery of Sierra Blanca, effective March 6, 2020.

#### 5. APPROVED TO LABOR WITHIN THE BOUNDS OF THIS PRESBYTERY:

In March, COM approved the request of the Rev. **Kristin Hutson**, of the Presbytery of East Iowa, to labor within the Presbytery of Santa Fe as a guest host for programs at Ghost Ranch, including worship leadership and presiding at the Sacrament of Holy Communion. Note: her service at Ghost Ranch was cancelled due to the COVID-19 suspension of Ghost Ranch programming.

At its March meeting, COM approved the renewal of the Contract of Mutual Understanding among the congregations of Cuba (NM), Rio Rancho, and Las Placitas for support of the Cuba (NM) congregation.

At its March meeting, COM asked the Presbytery to assist with advertising available positions for pastoral service in this presbytery, with Christian Century, Presbyterian Outlook, PCUSA Seminaries, and neighboring presbyteries.

At its June, 2020 meeting, COM received the resignation of Linda Wilson (Elder, Belen, First) from her COM membership, with appreciation and thanks for her work on and for COM. Her stepping aside allows for her more time for family care.

#### Report #1a - Rules of Decorum

- 2. That these be the guidelines for the conducting of business at this meeting:
  - a. Out of courtesy, when Presbytery is debating, all remarks shall be addressed to the moderator and shall be made from the floor.
  - b. In the interest of time and to allow as many as possible to speak, speeches will be strictly limited to 2 minutes. Persons wishing to speak should move to the appropriate microphone. So there is clarity, a speaker should begin by saying, "I speak for (or against) the amendment..."The moderator will rotate between calling on a person in favor, and then a person opposed, etc.

  - i. Any docket time allocated to a presbytery entity should not be used for fundraising purposes, capital or otherwise, unless approved by CT prior to that presbytery meeting.

Presbytery of Santa Fe Report of the Commission on Ministry (COM) October 17, 2020 by zoom teleconference

Since the last report to Presbytery on July 18, 2020, the Presbytery's Commission on Ministry (COM) met on Fridays, August 7, September 11, and October 2 by way of teleconference.

ACTION REQUIRING A VOTE BY PRESBYTERY: The Pastoral Call extended to Madeline Hart-Andersen, under care in the Presbytery of the Twin Cities Area (MN) from the Santa Fe, Westminster, Congregation on October 4, 2020, was slightly different from what COM had previously approved "if the way be clear". The Presbytery is now asked to approve the Call as extended and accepted, as follows: The Pastor is employed on a full-time basis, serving approximately 35 or more hrs/wk, and will be compensated as follows:

Cash Salary: \$5,000. Housing Allowance: \$40,000.

Board of Pensions dues paid in full, including medical, pension, disability and death benefit coverage under the Board of Pensions.

SECA: \$3442.50

Mileage: at 57.5 cents/mile; \$1,000.

Other vouchered allowances: \$500.

Continuing Education as vouchered: \$1250.

Continuing Education time of two weeks

(It is Presbytery policy that unused time and funds for Continuing Education may accumulate for up to three years.)

Vacation time of four weeks.

Moving costs as vouchered, up to \$. With the provision that of the amount, funds not used for moving may be applied to a down payment on the purchase of a home.

In the seventh year of service, the Congregation will provide for a three-month Clergy Renewal Leave, continuing the salary and benefits for that period, and providing for pulpit supply in the pastor's absence.

An addendum describes the parental leave guidelines.

#### NEW PASTORS RECEIVED AND/OR ORDAINED AND/OR INSTALLED

Sunday, October 4, was the first Sunday for **the Rev. Andrew Konigsmark** to serve as Pastor of the **United Church of Angel Fire**. Andrew is PCUSA and comes here from the Presbytery of Western Colorado. The Terms of Call will be available in the next COM report to Presbytery.

In September, COM approved the Call, if the way be clear, from the **Placitas, Las Placitas Presbyterian Church** to **the Rev. Richard Holmes**, currently of the Presbytery of Muskingum Valley (Ohio): as Designated Pastor for two years. The Congregation voted on October 4, to extend the Call

The Designated Pastor role is a contract for an agreed amount of time during which either the Pastor or Congregation may agree to part ways. The initial contract is for 2 years, which will be reviewed following the first year of service, and can be modified into a Solo Pastor position at any time as recommended by Session and approved by the congregation and the Presbytery. In addition to the compensation below, benefits include 4 weeks of paid vacation and 2 weeks of study leave, as well as up to \$10,000 for reimbursement of moving costs.

In September, COM received the report of the incoming examination of **the Rev. Andrew Konigsmark**, PCUSA, from the Presbytery of Western Colorado, the proposed candidate for the Pastor position at **Angel Fire**, **United Church**.

In October, COM received the report of the exit interview with **Dixon, Embudo**, following the departure of the Rev. Linda Loving.

- i. Any docket time allocated to a presbytery entity should not be used for fundraising purposes, capital or otherwise, unless approved by CT prior to that presbytery meeting.

The Presbytery of Santa Fe (the "Presbytery"), and Menaul School, Albuquerque, New Mexico ("Menaul") historically related in mission through the Presbyterian Church (U.S.A.) ("PCUSA"), in recognition of the enabling role of education in the proclamation and understanding of the Gospel of Jesus Christ and in furthering the hopes for peace, justice and freedom of God's people, affirm a covenant partnership.

# Whereas, in pledging our own commitment, the Presbytery of Santa Fe encourages our congregations to:

- 1. Pray regularly for the faculty and students and for the ministry and mission of Menaul;
- 2. Participate in available mission opportunities with Menaul School;
- 3. Celebrate Menaul School in worship annually on an appropriate Sunday and offer financial support to further the mission of Menaul;

- 6. Participate, through appropriate representation, on the Menaul Board of Trustees.
- 7. Support the relationship between Menaul School and the chaplain through the Presbytery's Commission on Ministry which fulfill the obligations of the presbytery stated in the *Book of Order of the PCUSA*: G3.0307.
- 8. Support the relationship between Menaul School and the Presbytery through the Committee on Representation and Participation by nominating the names of at least one Presbytery representative for each class to the Board of Trustees of Menaul School.

Whereas, the mission of Menaul School is to prepare students to succeed in mind, body and spirit; and

# Whereas, in pledging our commitment to continue in partnership with the Presbytery of Santa Fe, Menaul School will:

- Make every effort to fulfill its mission by upholding the central importance of diversity by providing an educational experience which furthers understanding of our global community;
- 2. Encourage our community to honor each other as diverse, unique and worthy individuals, inspired by God's grace, love and compassion;
- Promote critical thinking and foster lifelong learning through the development of intellectual curiosity, free and open inquiry and teamwork for living in an ever-changing world;
- 4. Cultivate a sense of call to responsible citizenship based on community service, environmental stewardship, non-violence and peacemaking to transform the world;
- 5. Nurture moral development in a community grounded in the Christian tradition, encouraging exploration and understanding of other traditions with respect;

  - b. The individual shall serve in a called position in accordance with the *Book of Order of the PCUSA:* G-2.0502. In the performance of that ministry, the minister of the Word and Sacrament shall be accountable to the presbytery and shall have membership in the presbytery by action of the presbytery and no pastoral relationship thus established may be changed, or dissolved without the approval of the presbytery, as provided by the presbytery's own rules (G-2.0901). However, recognizing Menaul School's right to manage its own employees, Menaul will consult with the presbytery, through its appropriate commission/committee, prior to making any changes to the chaplain's employment status, including termination or furlough, and/or elimination of the position.

The Presbytery ELECTED the following persons to serve as officers of the Corporation, The Presbytery of Santa Fe, a New Mexico non-profit Corporation, effective January 1, 2021: MWS Kathy Westmoreland, President; Elder Bill Belvin, Treasurer; Elder Stephen Rhoades, Secretary

The Corporation ADJOURNED and RECONVENED as The Presbytery of Santa Fe, a mid-council of the Presbyterian Church (U.S.A.), with prayer.

In January, COM received the Covenant between **Rio Rancho, Las Placitas, and the Cuba, NM** congregation, with occasional pastoral services to be provided to Cuba by the clergy from Rio Rancho and Las Placitas.

# **Report #1a – Rules of Decorum**

- 4. That these be the guidelines for the conducting of business at this meeting:

  - b. In the interest of time and to allow as many as possible to speak, speeches will be strictly limited to 2 minutes. Persons wishing to speak should move to the appropriate

- microphone. So there is clarity, a speaker should begin by saying, "I speak for (or against) the amendment..."The moderator will rotate between calling on a person in favor, and then a person opposed, etc.
- c. Remarks shall be confined to the pending question. The moderator will interrupt if in his/her judgment the speaker has drifted from the pending question.
- d. Commissioners may not refer adversely to prior acts of Presbytery not pending now.
- e. Remarks shall not impugn another commissioner or that person's motives.
- f. Distribution of reports or documents shall not be done during the meeting.
- g. Commissioners shall not disturb the meeting, by applause or verbal response to remarks made by a commissioner, or in response to a vote.
- h. Each commissioner may speak twice on a subject but may not speak the second time until everyone who wishes has spoken.
- i. Any docket time allocated to a presbytery entity should not be used for fundraising purposes, capital or otherwise, unless approved by CT prior to that presbytery meeting.

#### **ARTICLE III**

# **Territory**

The territory in which the Corporation's operations are principally to be conducted is the territory shown within its geographical boundaries on Exhibit "A", which is attached to and made a part of these Bylaws.

The territory includes the New Mexico counties of Bernalillo, Catron, Cibola, Colfax, Harding, Los Alamos, McKinley, Mora, Rio Arriba, San Juan, San Miguel, Sandoval, Santa Fe, Sierra, Taos, Torrance, Union, Valencia, and most of Socorro county including Socorro and Magdalena.

Stated Clerk Rhoades presented a first reading of proposed revisions to the Standing Rules. The revisions allow for electronic meeting and voting, as well as changes to align the Standing Rules with the By-Laws. The proposed revisions will be voted on at the February 2022 meeting.

Stated Clerk Rhoades reported that the disciplinary case toward Rev. Lorelei Kay has been completed. The terms of the supervised rehabilitation have been satisfied and the Permanent Judicial Commission has received and approved the final report from the supervisory team. Moderator Westmoreland led the Presbytery in prayer for those involved in resolving the disciplinary case.

The Presbytery **APPROVED** the Stated Clerk's recommendation that Albuquerque Immanuel, Albuquerque La Mesa, Albuquerque Sandia, Albuquerque Second, Rio Rancho, and Taos First be allowed an additional commissioner for 2022. # XIV. ADMINISTRATIVE COMMISSION FOR GALLUP, WESTMINSTER REPORT

MWS Lou Knowles reported that the commission is working with the members of the congregation to consider next steps for pastoral leadership.

#### XV. CAMINO DE VIDA TASK FORCE REPORT

MWS Jeff Finch shared a review of the work of the Task Force since it began in October 2019. The Task Force has completed its charge by determining that Camino de Vida should remain a new church development at this time.

Presbytery **APPROVED** to dismiss the Task Force with thanks.

MWS Seth Finch presented the motion that the Presbytery create an Administrative and Advocacy Commission to Camino de Vida with the purpose of providing a supervising entity in conjunction with the Evangelical Lutheran Church of America.

Presbytery **APPROVED** to authorize and charge an Administrative and Advocacy Commission to Camino de Vida.

## Motion to authorize and charge to an Administrative Commission

- 1. An Administrative Commission be created, in this instance being termed and Administrative and Advocacy Commission (AAC) consisting of 3-5 people from the Presbytery of Santa Fe. As outlined in the Presbytery's Standing Rules, members will serve in rotating classes of 3 years, with a maximum service of 6 consecutive years.
- 2. The AAC's purpose is to be the administrative and advocacy connection for Camino de Vida and its missional pastor to the Presbytery. The AAC will interface primarily through the Commission on Ministry (COM), though also collaborate with the Mission Networking Committee, as appropriate. Matters regarding funding of Camino de Vida and its missional pastor will be coordinated with the Finance and Property Commission (F&P). Sabbatical arrangements will be coordinated with COM.
- 3. Camino de Vida, a non-chartered fellowship under the auspices of the Rocky Mountain Synod of the ELCA and the Presbytery of Santa Fe, has its own Steering Committee (Comité Directivo). However, as a type of New Church Development, Camino de Vida's Steering Committee is not vested with the authority normally assigned to a Session. The AAC for Camino de Vida, for the foreseeable future, therefore will assume Session-related responsibilities where such capacity benefits Camino de Vida and its missional pastor.
- 4. The AAC will have the ability to act on behalf of the Presbytery in ecumenical matters relating to the ELCA, including activities and function of the ministry, training and development.
- 5. The AAC is charged with proposing adjustments to the missional pastor's salary, overseeing the budget of Camino de Vida, and proposing sabbaticals for the missional pastor, in concert with F&P and COM, and bringing those initiatives to fruition. Substantive actions of the AAC will be reported at the subsequent meeting of the Presbytery.

Moderator Westmoreland has appointed MWS Jeff Finch, RE Bryan Beck, RE Anita Torres, and RE Ester Griego to serve on the AAC.

## XVI. FINANCE AND PROPERTY COMMISSION REPORT

RE Kathy Rhoades presented the 2022 budget.

Presbytery **APPROVED** the 2022 budget as presented.

Kathy reminded the Presbytery that in 2018 it approved a recommendation to set aside 3% of the income from investments to be spent on special projects. Although the funds have been set aside, they have not been spent. The Commission presented Spending Policy Disbursement Proposal.

Presbytery **APPROVED** the Finance and Property Spending Policy Disbursement Proposal.

## Finance and Property Spending Policy Disbursement Proposal

This proposal is to determine the method of disbursing from this account for special projects and other initiatives of the Presbytery.

An ad hoc committee made up of 6 persons (one from COM, one from CPM, one from F & P, the moderator or moderator elect, and two at large members (one Minister of the Word and Sacrament and one Ruling Elder) would meet to determine how best to use these resources. Each committee appoints their representative and the moderator appoints the two at large members.

The charge of this ad hoc committee would be to receive, consider and recommend funding requests, and bring them to Finance and Property Commission for final consideration.

These projects could be multi year projects, however each individual calendar year should not exceed \$40,000. No funding is currently available for any projects expected to last longer than three years.

Presbytery **RECEIVED** the report of the Finance and Property Commission as part of the consent agenda.

#### Finance and Property Commission Report

F&P held meetings on June 25 and August 23, 2021.

## **Actions Taken On Behalf of Presbytery:**

- Approved a request from First Presbyterian Church, Raton to sell the property on 6<sup>th</sup> Street.
- Approved a request from First Presbyterian Socorro to sell unused land.

## **For Information:**

- Finance and Property has reviewed the detail financials with Financial Assistant, Chad Poole and reviewed the investment portfolio with the financial advisor.
- F&P has reviewed the Presbytery's insurance policies and adjusted the property coverage at the Camino de Vida property. The Church Mutual umbrella policy of the Presbytery and associated churches will continue, and the full cost of the policy will be included in the annual budget.
- The commission recommends that churches in the Presbytery of Santa Fe have an insurance policy of at least \$1 million and \$3 million aggregate, include officers/directors/trustee protection of at least \$500,000, include sexual misconduct liability, and include additional protection for childcare. The commission also recommends that all churches have an additional umbrella policy.
- F&P decided that Per Capita will remain the same for 2022, \$35 per person.

Treasurer Bill Belvin reviewed the financial reports showing the Presbytery's financial status as of September 30<sup>th</sup>.

## XVII. COMMISSION ON PREPARATION FOR MINISTRY

MWS David Whiteley informed the Presbytery that Christin Moreland has been examined and approved for candidacy status by CPM. Christin Moreland shared her recent faith journey and ministry experiences while in seminary.

David informed the Presbytery that CPM is reviewing and revising the process for commissioned ruling elders.

Presbytery **RECEIVED** the report of the Commission on Preparation for Ministry as part of the consent agenda.

## Commission on Preparation for Ministry Report October 16, 2021

CPM has met online monthly, except in July, throughout 2021.

## **Actions on behalf of Presbytery:**

1) CPM APPROVED to move Christin Moreland to the candidacy phase.

#### **Other Actions:**

- 1) CPM met with potential CRE inquirer Frank Shope, member at Sandia Presbyterian and former minister ordained by Southern Baptist conference, and made recommendations to begin the process.
- 2) CPM completed an annual consultation with Daniel Williams and approved Daniel to continue as a candidate. CPM is pursuing alternative means for Daniel to fulfill the requirement of clinical pastoral education.
- 3) CPM requests the transfer of inquirer Edward Lewis from Grace Presbytery to Santa Fe Presbytery.
- 4) CPM is considering changes to the process for commissioned ruling elders and commissioning elders to serve in specific capacities in the church are receiving the specified training.

## XVII. GATHERING IN NETWORKING GROUPS

The report from the Mission Networking Coordinators was moved to the afternoon due to the meeting running behind.

Participants gathered in groups of interest between Mission Networking, Education Networking, and Worship Networking to discuss the current work of the Coordinators and possible plans for future networking.

Presbytery recessed for lunch at 12:25 pm.

At 1:10 pm, time was given for announcements to be shared.

The meeting reconvened with prayer led by Moderator-Elect Clara Storms at 1:20 pm. The moderator-elect moderated the remainder of the meeting.

#### XIX. MISSION NETWORKING COORDINATORS REPORT

MWS Roger Scott Powers shared that the Family-to-Family fund has helped 99 families since April 2020.

RE Conrad Rocha, Stated Clerk for Synod of the Southwest, and RE Nelson Capitan thanked the Presbytery and the churches for supporting the Synod's Native American COVID Relief program. They shared a presentation of the food boxes that were packed and delivered to Native American families.

Moderator Kathy Westmoreland reported that she has been in conversation with Presbytery and Native American leadership regarding the burials in 4H Park in Albuquerque related to the Albuquerque Indian School. The city has recently responded with an apology and is working on a response to the burials with Native American leadership. She hopes to present a response from the Presbytery at the February 2022 Presbytery meeting.

## **Report #1a – Rules of Decorum**

- 5. That these be the guidelines for the conducting of business at this meeting:

  - g. Commissioners shall not disturb the meeting, by applause or verbal response to remarks made by a commissioner, or in response to a vote.

- h. Each commissioner may speak twice on a subject but may not speak the second time until everyone who wishes has spoken.
- i. Any docket time allocated to a presbytery entity should not be used for fundraising purposes, capital or otherwise, unless approved by CT prior to that presbytery meeting.

#### FINANCE AND PROPERTY COMMISSION (F & P) ANNUAL REPORT

2021

Even amidst the continuing COVID-19 pandemic climate, one thing remained faithfully stable: the financial status of the Presbytery thanks to church stewardship. Even while facing real or potential financial uncertainty, the churches of the Presbytery continued to give to the Presbytery. Per capita giving was \$135,957 (an increase of \$4,000 over the 2020 per capita giving) and unified mission giving was \$176,735, which was in line with 2020. This total per capita and mission giving was in excess of \$312,000. This financial support from the churches is inspiring and appreciated.

The Presbytery continues to be blessed financially in the appreciation of its investment portfolio reflecting general stock market gains over 2021. Our outside managed investment portfolio rose to a year-end level of \$2,103,859.

As to the operating budget for the Presbytery, the total operating income was \$459,108 with total operating expenses of \$430,766 for a small buffer of almost \$30,000 of income in excess of expenses. The primary change from 2020 was the increase in income from \$393,950 to \$459,108.

As for F & P, all of our meetings were on Zoom except for a retreat which was in-person, masked and distanced. I wish to gratefully thank the members of F & P who served during 2021: Carolyn Rhodes, Carol Cochran, Marty Bruner, Robert Busch and Judi Haines as well as our exofficio members: Bill Belvin, Treasurer; and Presbytery staff, Chad Poole and Tiffany Lo-Finch. Each one of these members contributed their expertise, knowledge and viewpoint to the work of F & P.
